**WHEREAS**, the Hamiltonban Township Board of Supervisors supports intergovernmental cooperation with neighboring Adams County municipalities in all areas of joint cooperation and services, and

**WHEREAS**, Hamiltonban Township is renting chipper and lift for tree trimming for one month and,


**WHEREAS**, Liberty Township has approached Hamiltonban Township to contract to share rental cost, 50% each, and staff and time 50% each, with the goal to trim trees on certain roads in Hamiltonban Township and Liberty Township for the safety of their residents and,


**WHEREAS**, the Board of Supervisors of Hamiltonban Township and the Board of Supervisors of Liberty Township shall enter into an Intergovernmental Service Agreement and,


**NOW, THEREFORE, BE IT RESOLVED** that the Board of Supervisors of Hamiltonban Township does hereby adopt this resolution this 21<sup>st</sup> day of September, 2021 at its regularly scheduled meeting which was duly convened in accordance with the law.





**WHEREAS**, an Intergovernmental Service agreement is defined as "an agreement between municipalities where one municipalites agrees to share cost and services, and


**WHEREAS**, Hamiltonban Township and Liberty Township agree to the following:

1. For the estimated fee of \$4,265.00 for one month, Hamiltonban Township Board of Supervisors agrees to provide chipper and lift with operator for one month.
