Fee Resolution for the Driveway Construction Ordinance

WHEREAS, on this 20th day of April, 2021, the Township Board of Supervisors of the Township of Hamiltonban enacted and ordained Ordinance No. 2021-02 Driveway Construction, an Ordinance regulating construction, correction of improper work, maintenance and repair of driveways in the Township of Hamiltonban; and

WHEREAS, pursuant to Section 1 of the aforesaid Ordinance, the Board of Supervisors of the Township of Hamiltonban shall establish and may amend from time to time by resolution fees and charges imposed upon any person for the issuance of a permit to construct, maintenance, repair or correct any driveway in the Township of Hamiltonban and all related activities regulated by said Ordinance; and

WHEREAS, the Board of Supervisors of the Township of Hamiltonban desires to adopt a resolution establishing all required fees and charges imposed upon any person for the issuance of a permit in the Township of Hamiltonban and all related activities under its Ordinance regulating driveways.


WHEREFORE, BE IT RESOLVED, that the Board of Supervisors of the Township of Hamiltonban does hereby adopt the following fees and charges pursuant to its Ordinance regulating driveways:


1. A permit fee is hereby imposed in the amount of \$50.00 per permit to be paid with application to the Township.
2. A minimum inspection fee is hereby imposed in the amount of \$50.00. An additional fee based on the then current hourly rates charged by the Township Roadmaster shall be invoiced by the Township and paid by the applicant after completion of the work. These fees will be reasonable and customary. The applicant shall notify the Township a minimum of seventy-two (72) hours in advance of final restoration to schedule an appointment to have a representative of the Township inspect the excavation prior to final restoration and covering.
3. Consistent with Section 3.E of the Ordinance, satisfactory liability insurance by or on behalf of the applicant shall be maintained and provided to the Township.
4. All other resolutions or parts of resolutions inconsistent herewith are hereby repealed.
5. The provisions of this Resolution may be amended according to law by a resolution duly adopted by the Board of Supervisors of the Township of Hamiltonban.
6. This Resolution shall take effect upon adoption.






