WHEREAS, Section 7503 of the Pennsylvania Emergency Management Services Code, 35 Pa. C.S. Section 7101 et seq. mandates that Hamiltonban Township prepare, maintain and keep current an emergency operations plan for the prevention and minimization of injury and damage caused by a major emergency or disaster within Hamiltonban Township; and


WHEREAS, in response to the mandate stated above, Hamiltonban Township has prepared an emergency operations plan to provide prompt and effective emergency response procedures to be followed in the event of a major emergency or disaster; and

WHEREAS, Hamiltonban Township has also prepared an emergency operations plan in order to reduce the potential affects of a major emergency or disaster and to protect the health, safety and welfare of the residents of Hamiltonban Township;




ADOPTED, this resolution this 6<sup>th</sup> day of September 2016 at its regularly scheduled meeting which was duly convened in accordance with the law.



THIS PLAN SUPERSEDES ALL PREVIOUS PLANS.


