
**WHEREAS**, the Board of Supervisors of Hamiltonban Township has determined that certain revisions are necessary and in the best interest of the Township;







## Hamiltonban Township 2022 Fee Schedule

### SALDO Review Fees

SALDO Review Fees shall be paid by the applicant in accordance with the set forth herein below schedule:

Developer's Escrow Account Amounts - A deposit of \$550.00 (includes a \$50 administrative fee) minimum is due at the time a plan is submitted to the Township. The escrow account is to be used as an offset for engineering, legal and other professional consultant fees actually incurred in the review of plans. Should the deposit amount be reduced to the sum determined in the Escrow Agreement, the developer shall be obligated to replenish the account to the original amount upon request. Any excess funds will be refunded to the developer once all invoices from the consultants have been paid.

Lots 1 -5	\$55.00	base fee, plus \$15.00 per lot
Lots 6-50	\$100.00	base fee, plus \$12.00 per lot
Lots 51-100	\$100.00	base fee, plus \$10.00 per lot
Lots 101 and over	\$100.00	base fee, plus \$5.00 per lot

#### Agricultural and Industrial Lots

(Non-Residential):	\$100.00	per lot
First acre	\$100.00	
Acre 2 – 10	\$100.00	base fee, plus \$50.00 per acre
Acre 11 and over	\$100.00	base fee, plus \$25.00 per acre

### Zoning Fees

In accordance with Section 501 of the Hamiltonban Township Zoning Ordinance, a building permit is required for the erection, alteration, or expansion of any building or structure, including signs, within the Township. A Land Use/Zoning Permit is also required prior to a change in land use or prior to a change or expansion of a non-conforming use or sign. The following fees are for permits issued by the Zoning Officer - Land and Sea Services, LLC.

Geothermal Well (closed loop only)	\$75.00	per well

Residential structure over 250 square feet	\$50.00	base fee, plus \$0.20 per square foot
Land Use Permit/Commercial (zoning permit)	\$50.00	base fee
Commercial structure over 250 square feet	\$50.00	base fee, plus \$0.25 per square foot
Accessory Buildings Permit (zoning permit)	\$50.00	base fee, plus \$0.05 per square foot
Sign Permit – up to 16 sq. ft.	\$25.00	per sign
Sign Permit – 16 sq. ft. to 40 sq. ft.	\$50.00	per sign
Sign Permit – 40 sq. ft. and over	\$100.00	per sign
Uniform Construction Code Fee (building permit)	\$50.00	per permit
Accessory Dwelling Unit Annual Permit Renewal	\$80.00	per permit

**Other Zoning Filing Fees**

Conditional Use Application	\$2,000.00	plus any additional charges
Zoning Hearing Board - Variance/Special Exception	\$2,000.00	plus any additional charges
Zoning Ordinance Amendments/Map Changes	\$2,000.00	plus any additional charges

In addition to the filing fee, the Township will charge any allowable costs (for example, associated with additional hearings) incurred by the Township that exceed these fees. The cost billed by Stenographer will be billed 50% to the applicant plus an administrative fee of \$5.00.

**Floodplain fee** – based on all consultant’s costs. Developer shall pay the hourly rate charged to the Township for review by any consultant the Township deems necessary to review said plan(s), plus administrative fee of \$50. Such costs shall include but not be limited to:

The definition of “consultant” shall include the services of the Engineer, Solicitor, Building Code Official, Zoning Officer, Sewage Enforcement Officer, or other professional or specialist whose services the Township deems necessary.

**Adams County UCC Shared Board of Appeals:** \$1,050.00 plus in addition to the filing fee, \$50 administrative fee, the Township will charge any allowable costs associated with hearings incurred by the Township that exceed these fees.
