SALDO Review Fees

SALDO Review Fees shall be paid by the applicant in accordance with the set forth herein below schedule:

Developer's Escrow Account Amounts - A deposit of \$550.00 (includes a \$50 administrative fee) minimum is due at the time a plan is submitted to the Township. The escrow account is to be used as an offset for engineering, legal and other professional consultant fees actually incurred in the review of plans. Should the deposit amount be reduced to the sum determined in the Escrow Agreement, the developer shall be obligated to replenish the account to the original amount upon request. Any excess funds will be refunded to the developer once all invoices from the consultants have been paid.

Zoning Fees

A Land Use/Zoning Permit is also required prior to a change in land use or prior to a change or expansion of a non-conforming use or sign.
