Resolution Number 2021-07 Hamiltonban Township, Adams County, Pennsylvania

Fee Resolution for the Highway Occupancy Ordinance

WHEREAS, on this 16th day of March, 2021, the Township Board of Supervisors of the Township of Hamiltonban enacted and ordained Ordinance No. 2021-01, an Ordinance regulating streets and street excavations in the Township of Hamiltonban; and

WHEREAS, pursuant to Section 4 of the aforesaid Ordinance, the Board of Supervisors of the Township of Hamiltonban shall establish and may amend from time to time by resolution fees and charges imposed upon any person for the issuance of a permit to open or excavate any street in the Township of Hamiltonban and all related activities regulated by said Ordinance; and

WHEREAS, the Board of Supervisors of the Township of Hamiltonban desires to adopt a resolution establishing all required fees and charges imposed upon any person for the issuance of a permit to open or excavate any street in the Township of Hamiltonban and all related activities under its Ordinance regulating streets and street excavations.

WHEREFORE, BE IT RESOLVED, that the Board of Supervisors of the Township of Hamiltonban does hereby adopt the following fees and charges pursuant to its Ordinance regulating streets and street excavations:

- 1. A permit fee is hereby imposed in the amount of \$90.00 per permit. The permit shall allow the applicant to close portions of the street for a period not to exceed three (3) days per opening, or as required, upon written receipt of a request by the Township.
- 2. A street closing fee is hereby imposed in an amount no less than \$250.00 for each day that the street is closed for traffic by reason of opening or excavation under the permit.
- 3. A minimum inspection fee is hereby imposed in the amount of \$75.00. An additional fee based on the then current hourly rates charged by the Township Engineer shall be invoiced by the Township and paid by the applicant after completion of the work. These fees will be reasonable and customary. The applicant shall notify the Township a minimum of seventy-two (72) hours in advance of final restoration to schedule an appointment to have a representative of the Township inspect the excavation prior to final restoration and covering.
- 4. A degradation fee is hereby imposed to an applicant for a street opening or excavation on a sliding scale, based upon the number of years after a street has been paved. The minimum charge will be for two (2) square yards rounded to the next whole square yard.

Those charges will be:

- 5. Consistent with Section 3.C of the Ordinance, satisfactory liability insurance by or on behalf of the applicant shall be maintained in the minimum coverage amount of One Million (\$1,000,000) Dollars.
- 6. All other resolutions or parts of resolutions inconsistent herewith are hereby repealed.
- 7. The provisions of this Resolution may be amended according to law by a resolution duly adopted by the Board of Supervisors of the Township of Hamiltonban.
- 8. This Resolution shall take effect upon adoption.
